

These fees are per person and they were calculated based on the GDP per capita of each country. These amounts already include the carbon off-set fee of $5 \in$ for western countries and $2,50 \in$ for eastern countries. This system of participation fees was approved and agreed by the General Assembly of MIJARC Europe.

Nevertheless, if you have any personal reason that limits you to pay the fee attributed to your country please contact the person responsible for the activity from your country.

All the participants are responsible to find and book by themselves the cheapest way to travel to Munich (if they're coming by plane) or to Passau (if they're coming by train or by car) and from Munich/Passau back home.

If you come to Munich by plane, we will provide a bus to take you from the airport to Passau.

Reimbursement of travel costs

Travel costs will be reimbursed to you, or who paid for it in advance under the following conditions:

- Only cheapest means of transportation and fares will be reimbursed (e.g. 2nd class tickets).

- A bank transfer will be made as soon as we receive all the original receipts/invoices, boarding passes and tickets from your travel and according to the following table!
